Standing on a plot of 678 sqm, this elegant, timeless villa is situated on a plot of approx. 678 sqm in a desirable location in Son Moja. A special feature is provided by the beautiful bay of Cala Santanyi which is only approx. 800 m away. The lively village of Santanyi with its exclusive restaurants and shopping facilities can be reached in just a few minutes.

A living space of approx. 271 sqm is spread over 2 levels. On the ground floor a light-flooded entrance area welcomes and leads into the openly-designed living/dining area with fully equipped fitted designer-kitchen, and a traditional natural-stone wall in the living area bestowing great Mallorcan charm. Also on this floor are a double bedroom with en-suite bathroom and a guest WC. The bedroom has direct access to the garden.

On the upper floor there are 2 further bedrooms, and a bathroom which is accessible from both bedrooms. One of the bedrooms is a large master-suite with an en suite bathroom, and all bedrooms have direct access to a large terrace from where a spiral staircase leads up to a roof terrace providing breathtaking sea views, the perfect place to create lovely chill-out area.

In the exterior area is the 10 x 3 m pool and an attractive barbecue area, and the entire villa is surrounded by a well-maintained garden. The specifications are rounded off by an outdoor parking space with an electric gate, and exclusive

features including an alarm system, air conditioning, and underfloor heating.
