Описание объекта:

This enchanting chalet with countryside views is situated in a quiet residential area near to the natural park of Cala Mondrago and to Cala Figuera. The wonderful, turquoise-blue sea and the harbour of Cala Figuera are only a few minutes away.

The lovely, well-maintained chalet has a living space of approx. 240 sqm. On the ground floor is the openly-designed living/dining area, an adjacent, fitted open kitchen with breakfast bar and access to a beautiful terrace with garden views, a double bedroom and a bathroom.

Stairs lead to the upper floor with 3 further light-flooded bedrooms and a bathroom. All bedrooms have access to a private terrace from where wonderful views of the surrounding nature can be enjoyed.

The house has a complete cellar, and a separate guest apartment with a large living area, a bedroom, and a kitchen. The living room accesses a covered terrace with a lovely bbq zone, the perfect shady place to spend convivial time with family and friends during the summer months.

A lovingly laid out exterior area is bordered by a green zone and provides a tranquil oasis surrounded by nature where, thanks to the west-facing orientation, the sunshine can be enjoyed all day long. A large pool with outside shower provides welcome refreshment in summer, and distributed over the whole plot are ample relaxing seating areas.

This exceptional property also has a touristic rental licence for up to 8 persons, making it ideal both for owner occupation and as an investment.

The harbour of Cala Figuera with its cafes and restaurants is only a few minutes walk away, and the beautiful beaches of s'Amarador and Cala Mondrago are easily reached by bicycle.
