#### Описание объекта:

The main house set on a plot of approx. 13,112 sqm has a living area of 279 sqm spread on 2 floors and every room offers a distant view to the bay of Pollensa. From the roof terrace, you have views to Formentor, to the peninsula of Victoria and a large part of the Tramuntana Mountains as well as to the bay of Pollensa.

The main level of the house can be accessed by 3 entrances. The classic architecture of the floors has a U-shape with 2 wings. The central living and dining area consists of 3 very large halls featuring 2 fireplaces. The east wing of the house comprises 2 bedrooms, a bathroom as well as another hall with a fireplace. The west wing allocates 2 bedrooms, a bathroom as well as the kitchen (also with a fireplace). A covered terrace along the complete front of the house leads directly to the pool by a broad representative staircase.

On the ground floor, there are 2 separate bedrooms with bathroom respectively as well as a small apartment comprising a bedroom, a bathroom and a live-in kitchen.

Furthermore, there is an unused space of approx. 120 sqm, which could be converted into further rooms.

The exterior features a tennis court, a garage comprising the heating, a garden shed and a small house for the electricity meter as well as a room for the pool equipment.

The house needs renovation and a large part of the outdoor facilities have to be refurbished. Due to the good basic structure of the building the refurbishment is manageable and the price is attractive.
